

2010-11 Chaparral Ice Center High School Hockey

Terms and Conditions

1. The parent or guardian of the below mentioned player declares that the player is in good physical and mental condition and does not possess any medical history of major problems, past injuries, allergies, special conditions and/or restrictions that would prohibit him/her from participating in the game of competitive youth hockey.
2. Parent and player assume all risk and danger incidental to ice skating in general, and the game of ice hockey in particular. These risks and dangers include, but are not limited to, the danger of being injured by pucks, hockey sticks, skates, or other players. The parent and guardian also agree that Chaparral Ice, Youth Hockey Foundation of Austin, and USA Hockey are not responsible for any loss of or damage to any personal property.
3. Parents have reviewed and completed all of the registration documents and are aware of the potential cost and expenses incurred with their child playing high school hockey.
4. Deposit is due upon enrollment. Registration payments are only required if the player plans to play on a Central Texas High School Hockey League team. If a parent or guardian fails to remit registration payments, the named player will be removed from the team roster.
5. Once the player's deposit payment is paid and this form is signed, the player agrees to play, barring injuries, on the High School team for which they were assigned to and may not roster on another ice hockey high school team, unless released in good standing. Such releases will only be considered after association and team dues are satisfied.
6. The parent or guardian agrees that all registration payments made are non-refundable and will be applied toward their season registration fee. Pro-rates will only be considered if a player is injured, has a Doctor's note or recommendation and can't skate. Otherwise no refunds, exchanges or pro-rates will be given.
7. Full ice hockey equipment, as required by USA Hockey, must be worn at all times.
8. The player, parent or guardian must abide by the rules of Chaparral Ice Center, the High School team for which the player was assigned, the Youth Hockey Foundation of Austin, and by the rules of conduct of USA Hockey and TAHA.
9. Unauthorized use of the Roadrunner logo is strictly prohibited
10. Rink Management and the coaches reserve the right to remove any skater from the ice if in their opinion, the skater's conduct warrants such action to be taken.
11. Please have respect for all facilities provided by Chaparral Ice Centers. Damage to the property can and will result in disciplinary actions up to and including fines, suspensions, and possible removal from the hockey program.

Liability Waiver

Ice Skating, hockey, and other ice sports and the use of rental equipment for ice skating and other ice sports involve certain inherent risks, dangers and hazards, which can result in serious personal injury. The skater/participant and/or the participant's parent or legal guardian assume and accept all risk of personal injury while in the Chaparral facility. At all times the skater/participant and/or the skater's/participant's parent or legal guardian shall be fully liable for personal injury and property damage incurred while on the premises. And, the skater/participant and/or the skater's/participant's parent or legal guardian agree to hold Chaparral, its officers, agents and employees harmless against any and all liability for claims, demands and causes of action asserted against Chaparral arising from skater's/participant's use of the facilities or otherwise, upon the premises.
