Basic 1 – 8 students:

Camp des Champs is an all day camp program designed to provide daily lessons and practice time for participants in our Learn To Skate program. This program is aimed at skaters in Basic 1 through 8 with an interest in pursuing a higher level of figure skating. The students will receive two group lessons per day with additional practice time. Skaters will also receive off ice instruction and education related to figure skating.

Freeskate 1 – 6 students:

Although this program is designed for skaters in Basic 1 – 8, we welcome students at the Freeskate levels. As there are fewer students at this higher level, there is a possibility of there not being enough students. We will make every effort to accommodate skaters at the Freeskate levels. If registration is low, the camp may have to be cancelled for the skaters at this level. We will inform the registered skaters as soon as possible if this is the case. Skaters in the Freeskate levels will receive one lesson per day with additional practice time. Students with private instructors are welcome to and encouraged to take private lessons during the practice ice times. Skaters will also receive off ice instruction and education related to figure skating.

Activities: The camp will consist of activities other than ice skating, such as: arts & crafts, watching skating videos and movies, indoor group games, gym games, playtime at nearby park, off-ice exercises, figure skating training information and education.

Payments: You may pay in full or pay a \$100 deposit to reserve a spot for your child. A deposit must be paid for each week in which you wish to reserve a spot for your child. If you pay a deposit, the remainder is due prior to the start of the camp week. There are no daily fees or ½ days. You should pick up your receipt for payment when your child in so that you have it for tax purposes. If you wish to have receipts mailed to you during the tax season, you will need to mail your request with a check for \$5 for processing.

Refunds: There is a 30 day cancellation policy. Refunds requested more than 30 days prior to the start date for a particular camp session will be processed minus a \$20 non-refundable administrative fee. If you cancel within 30 days of the start date, \$50 is forfeited. If you cancel within 15 days of the start date, \$100 is forfeited. The only exceptions made to the above policies will be for long term illness or injury. A medical refund request must be submitted with a doctor's statement to the Camp Director. A \$20 non-refundable administrative fee will be deducted plus a prorated amount for each day of camp attended. Camp fees and deposits are transferable to other weeks if requested one week prior to the start of that particular camp week and on a space available basis. Transfer request must be received one week prior. Occasionally, there are unfortunate incidences beyond our control such as equipment failures or severe weather. There are no refunds for such incidences.

Availability: Space is limited and is first come, first serve. Chaparral Ice reserves the right to cancel or close any camp sessions. Chaparral will notify paid participants of any cancellations ahead of time, if possible. Chaparral will issue refunds within 30 days to any paid participants.

Sign-in / Sign-out Procedures: For your child's safety, we require parents to sign their child in every morning and sign them out in the afternoon. Only authorized persons listed on your child's registration form, including the parents/guardians listed as well as the emergency contact, will be allowed to sign your child out. Please allow a few extra minutes for signing in/out and bring a photo ID as the camp staff will need to verify who is signing the child out.

Late Pick-ups: Your child must be picked up by 6:00pm everyday. You will be charged \$1 per minute after 6:05pm, payable immediately. After five late pick-ups, the fee increases to \$5 per minute. Your late fees must be paid before your child can return to camp.

Participation: My child is in good physical condition and has my permission to participate in all camp activities.

Transportation: I authorize my child to travel to/from camp activities in the Chaparral Ice vans or bus or other transportation arranged by Chaparral Ice.

Discipline: Please encourage your child to follow the instructions of counselors and Chaparral Ice staff. If needed, campers will be told of unacceptable behavior and asked to correct it, and "time out" may be given if the negative behavior persists. Behavior problems may result in a meeting with the Camp Director and a consultation with the parents. Chaparral Ice, at its sole discretion, reserves the right to expel any child from camp if negative behavior endangers the health, safety or well-being of another person. We cannot be responsible for children who will not cooperate or follow instructions. There will be no refunds for children who are expelled for disciplinary reasons.

Search Policy: To insure the safety of all campers, all bags are subject to search, without notice, by the management of Chaparral Ice. A copy of our search policy may be obtained for your review by contacting the Camp Director.

Accidents: In case of sickness or accident, Chaparral Ice has my approval to secure, at my expense, such medical attention as deemed necessary, if unable to contact me.

Medication/illness: Any medication to be administered to campers must: (1) be given directly to a camp counselor; (2) be in the original container with its original label; (3) and parents must fill out the medical authorization log. All medication must be kept in the camp office.

Parents please note: Although we will make every attempt to give the medicine on time, it is ultimately the camper's responsibility to notify the Camp Director when the medication is to be taken. If the medicine is to go home with the camper daily, it is the responsibility of the parent to sign it out from the camp office. Campers must have a shot record on file with Chaparral Ice. They should be brought the first day of camp.

Special Needs: The Camp Director should be notified if your child has special emotional or physical needs. We will make every effort to serve campers who have special needs, however, we will not accept campers who have needs beyond our training or capabilities.

Liability Waiver:

Ice Skating and ice sports involve certain inherent risks, dangers and hazards, which can result in serious personal injury. At all times the participant or the participant's parent or legal guardian shall be liable for personal injury and/or property damage or loss incurred while on the premises or while in the care of a Chaparral Ice camp, and the participant agrees to defend and hold Chaparral Ice Center, its officers, agents and employees harmless against any and all liability for claims, demands and causes of camper's use, maintenance and operation of the facilities or otherwise upon the premises or from the participant's negligence during the term of this agreement. All skaters must agree to abide by the posted Skater's Responsibility Code and acknowledge that all skaters skate at your own risk
